**MINUTES:**

Without objection or correction the February 12, 2015, minutes were approved. Motion made by I. Barrons, seconded by C. Sherwin – motion carried.

**ROBERT MANTEY (Tuscola County Drain Commissioner):**

Bob discussed the drain petition from the Village of Mayville. There will be a Board of Determination meeting on March 19<sup>th</sup> at 7 p.m. at the Fremont Township Hall. The new drain will be called the Fulton Drain which will be entirely in the Village of Mayville.

**CLERK REPORT:** Clerk was absent and C. Sherwin gave the Clerk's report.

Resolution to allow Resident & Non-Resident Written Protest to the Board of Review – Assessor informed the Clerk that the Township needed to adopt a Resolution passed to allow residents and non-residents to send written petitions to the Board of Review. C. Sherwin gave the Board members a copy of the Resolution that was provided by the Assessor. Motion to adopt the Resolution as presented made by J. Welke, seconded by I. Barrons. Roll call vote: H. Wymore-yes, J. Welke-yes, I. Barrons-yes, C. Sherwin-yes – motion carried.

**TREASURER REPORT:**

Treasurer balance was \$225,150.65 as of February 28, 2015. Motion to accept treasurer report made by I. Barrons, seconded by H. Wymore – motion carried. C. Sherwin gave the Board a report on the amount of taxes collected. He collected 88% of the taxes and balanced to the penny with the County. C. Sherwin also commented that the 2014 interest earned on the accounts was \$788.49.

**SUPERVISOR REPORT:**

Cemetery Report – Would like Wayne to finish marking the North Grove Cemetery lots with re-rod.

**NEW BUSINESS:**

Mosquito Control Tire Collection – H. Wymore is going to contact the Sherriff to see about getting some help. H. Wymore received a request from the EDC for \$650. Motion made by H. Wymore, seconded by J. Welke to sponsor the EDC for \$650 – motion carried.
