

Fremont Township Minutes
May 14, 2015

The regular meeting for the Fremont Twp. Board of Trustees was held on May 14, 2015, at 7:00 p.m. at the Fremont Township Hall.

Board members present: H. Wymore, A. Holbrook, C. Sherwin, J. Welke & I. Barrons. Absent: None
Guests: 4

MINUTES:

Without objection or correction the April 9, 2015, minutes were approved. Motion made by I. Barrons, seconded by J. Welke – motion carried.

PUBLIC COMMENTS:

A Resident commented that the siren pole looks much better. Also another Resident suggested that the labels on the left drop box at the hall be replaced because they do not look good.

CLERK REPORT:

Election went very well with no problems.

TREASURER REPORT:

Treasurer balance was \$262,046.07 as of April 30, 2015. Motion to accept treasurer report made by A. Holbrook, seconded by J. Welke – motion carried. C. Sherwin also let the Board know that he received a letter from the County Treasurer's office about 2 parcels that will be going up for tax sale. He recommended that we don't purchase them and let them go up for tax sale. The Board agreed and the Treasurer will sign and return the paperwork to the County Treasurer.

SUPERVISOR REPORT:

Cemetery Report – H. Wymore received a price from the Cemetery Caretaker for placing metal markers at the cemetery lots. The cost to finish the job at North Grove was \$280. Motion made by J. Welke, seconded by H. Wymore to approve the Caretaker to finish this job for \$280 – motion carried.

Road Report – H. Wymore received the estimate from the Road Commission for Hunt Road from M-24 to Wireline Road. The cost will be \$16,900. Motion made by H. Wymore, seconded by J. Welke to approve the work on Hunt Road – motion carried. H. Wymore also stated that he would like to do some work on some of the other gravel roads if possible. J. Welke mentioned that Phelps Lake Road from Maier to Lobdell is really bad and also O'Brien Road west of Leix Road. It was also mentioned about Leix Road off of Saginaw Road. H. Wymore suggested that the Board members maybe drive around this month and see which gravel roads they think may need more work.

Emergency Siren – H. Wymore would like to see us finish up the siren project. He has a bid for \$6,533 but the price does not include the \$100-\$200 that would be necessary for the electrical permit. He would like the Board to approve \$6,733 to complete the siren installation. Motion made by H. Wymore, seconded by C. Sherwin to approve \$6,733 to complete the project – motion carried.

Tire Collection – will be July 15th from 9am-3pm at the Township Hall.

H. Wymore also received a letter from the Heating & Cooling Company about cleaning the air condition for \$100. C. Sherwin stated that it hasn't been done for a couple years and J. Welke stated that it should be done. Motion made by C. Sherwin, seconded by J. Welke to approve the cleaning – motion carried.

BILLS: Motion to pay the bills as presented made by C. Sherwin seconded by J. Welke – motion carried.
